FROM THE PRESIDENTS DESK

PROTEST MARCH PORT MORESBY

A protest march took place in Port Moresby this morning. The latest Report from the Port Moresby Chamber of Commerce at 11:30 this morning - G4S Security advises that students at UPNG are leading a protest march against the controversial Judiciary Conduct Bill.

Initially the demonstrators were stopped by Police inside the University gates and were advised by CO Anderson Bawa not be allowed to proceed.

A huge crowd however later went past the North Waigani Traffic lights heading towards parliament. The POMCCI has cautioned members to avoid the area if possible and that they should exercise care when travelling in the area from University to Sir John Guise Drive on to Parliament or avoid the area altogether until the tension settles.

As normal when this type of occurrence happens in Port Moresby, it usually flows on to other centres. The Police have not heard of any demonstration in Lae, but they are monitoring the situation and will advise us if anything happens. We of course will pass any message into members.


