Security Battle

The battle between security companies - Guard Dog Security Services (GDSS) and Executive Security Services (ESS) that we reported in last week's newsletter has ended with the Police meeting the Management of both companies and both Managing Directors shaking hands and agreeing to take all steps to end the hostilities that saw the flare up between the two companies over much of last week. Both sides have agreed to let the Police investigate the affair and to take action against any of the perpetrators within their own ranks who have broken the law.

In our newsletter last week we published a letter from the GDSS Managing Director and to be fair to both companies, we include at the end of this news update, an explanatory letter from the ESS M/D.

The Securities Industry Authority is also investigating the affair with the aim of seeing if there were any breaches of PNG Laws. They are particularly interested in firearms as they indicated on P.9 of the National this morning – *"Firearms information is very important for the Security Industries Authority to maintain our data base and to monitor weapon movements and their usages by companies. Firearms are now mainly used by firms to escort bank runs, VIP's and gold bullion from mining sites.*

"We do not know how many weapons there are, the types used and which security companies have them", the SIA Registrar Paul Kingston Isari said.

The Police Commissioner is the Registrar of Firearms under the Firearms Act, and he has already stated that he will be looking into the whole issue of firearms and use of firearms by security companies. This will be most welcome as we have received messages from members stating that shots were fired during the clash last week at many locations, which can only be interpreted as an abuse of the right to hold firearms.

A SENIOR United States government official says Papua New Guinea will continue to have development issues unless it brings its internet rates down like other Asia Pacific Economic Cooperation (Apec) member countries.

We do not need to wait for somebody from the outside to come to tell us that unpalatable truth, of course.

PNG's own Communication and Information Minister, Jimmy Miringtoro, has told us as much in recent days.

Information and communication technology charges are way too high in Papua New Guinea.

PNG telecoms minister issues wholesale service declaration

Jimmy Miringtoro, Papua New Guinea's minister for communications and information technology, has acted on the recommendation put forward by the National information and Communications Technology Authority (NICTA) earlier this month, which called for the declaration of certain wholesale services relating to access to submarine cable landing station facilities and transmission capacity on international submarine cables. Wholesale Service Declaration No.1 of 2013 will come into force 30 calendar days after it is published in the national gazette, and will last for five years.

As previously reported by CommsUpdate, following a six-month public inquiry NICTA concluded that fixed line incumbent Telikom PNG held a monopoly in the market for wholesale capacity on, and access to, international fibre optic submarine cables. Further, the study also found that Telikom's dominance in the sector was 'potentially har mful to the development of competition in many other telecommunications markets, including the retail market for broadband services'. In making its recommendation to the minister, NICTA claimed that a declaration of the services in question would make the wholesale access and utilisation of submarine cable transmission capacity more accessible and more affordable. In turn, it said, this should enable those companies to offer faster and more affordable broadband services to their customers. Listing the other expected benefits of the declaration, the regulator said that it should result in: lower prices for outgoing international communications; increased international bandwidth; greater utilisation of existing international capacity and increased investment by Telikom (as a result of increased demand); faster market growth via increased traffic and use; and because of the growth of broadband, potential for greater investment in submarine cable capacity.

Under Papua New Guinea's National Information and Communications Technology Act 2009, a telecommunications company that supplies a declared service that must comply with non-discrimination obligations.

There is no doubt that Internet rates in PNG are amongst the highest priced in the world. Yet businesses here are increasingly competing on the International market. PNG is committed to the tariff reforms that were agreed to by APEC countries and we have seen tariffs reduced over the years on a wide range of goods. A tariff reduction policy is fine but the problem in PNG is that the high cost of doing business in this country makes it very difficult to compete on the global market.

The fact that the internet charges are extremely high is exacerbated by the unreliability of the service that is offered. The following table was provided to us by a "reputable monitoring service" that shows there were significant **downtime** for the 9 lines from Lae in the past week which gives a good indication. In effect only 5 of the 9 lines were working with any degree of regularity, with the other 4 lines being out most of the time. This is simply not good enough and the situation must improve.

Hopefully the Communication Minister's above declaration will result in a change for a better and cheaper Internet service.

The story behind Garnaut's PNG expulsion

WHEN Prime Minister Peter O'Neill late last year decided that Professor Ross Garnaut was not welcome in PNG there was consternation in many quarters. Why this would happen to some one who had built a close connection with PNG over more than four decades was a question asked commonly enough. By Wantok*

On the surface it seemed the PM had been upset by a suggestion that he wanted to get his hands on the funds controlled by PNG Sustainable Development Program Ltd (PNGSDP), which had inherited the equity stake in the Ok Tedi copper/gold mine following the withdrawal of BHP Billiton.

In 2001, BH P had decided it preferred to shut the mine down because of the immense environmental damage it had caused since mining commence d in 1984. But because the government and local communities wanted the mine to go on, BHP decided to transfer its 52% stake to PNGSDP.

PNGSDP was given a broad mandate to help mitigate the impact of the planned mine closure in 2013 with a role of using one - third of Ok Tedi dividends for immediate development within Western Province and in the rest of the country. The rest of the money was invested in Sirgapore for long-term use after mine closure.

Right at the start, BHP appointed three of the seven PNGSDP board members and a Singaporean, because the entity was registered in Singapore. Only one of the other three members was a direct PNG government nominee, courtesy of the PNG Treasury. Garnaut, who had a long history in PNG dating back to pre-independence days, was made chairman.

To maintain its independence, the board was not required to report back to or take instructions from BHP Billiton, although it was required to submit annual reports.

In the past year, following recommendations from a peer review, BHP has given up its role of directly appointing the three directors, passing this task to the PNGSDP board.

In essence, the board was answerable to no one and was a law unto itself. There has been no mechanism in place to replace BHP-appointed directors. Prior to the recent change, one director, Jim Carlton, chose to retire and BHP unilaterally appointed an expatriate in his place.

All of this see ms innocuous enough. In fact, perceived probity is one of the key reasons why the national government acted the way it did against Garnaut and, indeed, was offended by the manner in which his successor as PNGSDP Chairman was chosen.

Prior to the change, Garnaut made a very sensible move and advised O'Neill that he was stepping down as PNGSDP chairman. O'Neill immediate began to contemplate who he might consider a good replacement.

Much to his consternation and surprise, the PNGSDP board, without prior warning, suddenly replaced Garnaut with former PNG prime minister Sir Mekere Morauta and presented this to O'Neill as a fait accompli.

Sir Mekere was one of the most highly respected former national leaders prior to his decision not to contest the 2012 national election. But there are many in high political office, possibly including O'Neill, who do not share his views.

Although Sir Mekere was responsible for financial sector reforms that be nefitted the national economy, while he was prime minister the country faced a serious recession with the situation deteriorating under his watch. Investors began to flee the country and pessimistic views held sway about the future of the nation.

The turnaround came with surprising speed when the Somare government took office in August 2002. Confidence in future economic directions grew steadily and then gathered momentum in subsequent years with the fillip providing by rapidly increasing commodity prices and the approval of the \$US19 billion PNG LNG Project.

The government's shock and anger at the manner in which Sir Mekere replaced Garnaut has its roots else where.

It was Sir Mekere as prime minister who approved BHP's withdrawal from the Ok Tedi mine and who agreed that PNGSDP would indemnify BHP Billiton against any future litigation over the environmental damages it had caused. This PNGSDP indemnity was also extended to the PNG government. What has made some political leaders irate is the possibility—and the perception – that Garnaut had been provided a plum role in PNGSDP and at the time Sir Mekere had agreed to the BHP departure. These leaders also fear there could have been an implicit understanding that one would replace the other if and when such an opportunity arose.

The latest peer review completed at the end of 2011 pointed to problems of transparency and accountability with PNGSDP, including criticisms that PNGSDP had circumvented the criteria for ongoing national development expenditure by questionably categorising projects within Western Province as "national projects".

The PNGSDP board has not responded to these criticisms and has conveniently swept them under the carpet as though these questions were not legitimate or that they did not require a response, confirming the view of some critics that they are a law to themselves.


AIR NIUGINI RESCHEDULING

Business Advantage PNG YOUR GATEWAY TO PAPUA NEW GUINEA AND THE REGION From this month, the European Union (EU) won't be accepting illegally produced wood products. What impact will its decision have on Papua New Guinea's forestry sector? PNG's direct exports of forest products to the EU are modest-just 0.2% of the exports in 2011. Of this, plantation-grown balsawood is the single largest export. A new EU ruling (EU Timber Regulation No.995/2010) bans the importation of illegally harvested and produced timber products **BUSINESS** into EU markets. But direct PNG exports to the EU are unlikely to be affected, according to Bob Tate, Executive Director of peak industry body, **ADVANTAGE PNG** the Papua New Guinea Forest Industries Association. **ARTICLES** The bulk of PNG's timber finds its way into overseas markets via China, which bought 78% of PNG forest exports, mainly round logs, in 2011. Much of this timber ultimately finds its way into the EU in manufactured products. 'PNG is the only country in the world with 100% independent third-party monitoring of its log exports... ' Industry responding to challenge While any lasting impact of the EU ruling is likely to be on these exports, the industry is confident it is taking the right steps to mitigate the risk. 'PNG is the only country in the world with 100% independent third-party monitoring of its log exports [by Swiss company SGS], so we are well-placed to meet these emerging regulatory requirements,' Bob Tate told Business Advantage PNG. 'We are also working with China's State Forestry Administration to make sure our systems are in sync with what they are doing.' In addition, Tate estimates that 50-60% of processed timber exports-which go mostly to Australia, New Zealand and the Pacific—are produced by the companies that have adopted Forestry Stewardship Council (FSC), the Programme for the Endorsement of Forest Certification regulatory and traceability standards or the SGSTLTV system for certification. The cost of certification Cloudy Bay Sustainable Forestry is one PNG company which plans to complete its FSC certification in 2013. ... any timber prevented from being exported to the EU through China might be dumped back on the PNG's home market, with devastating results... 'FSC certification isn't the cheapest thing to do,' notes Chairman Rob de Fegely, who expects the EU regulations, and those in markets such as the United States and Australia, to effectively put an end to the market for ill egally logged product. However, de Fegely notes that different regulations covering forest imports across the EU, United States and now Australia (which passed new legislation in 2012) could create problems for exporters. 'We would be disappointed if FSC certification wasn't enough and we had togo through another process as well,' he said. He also expressed concern that any timber prevented from being exported to the EU through China might be dumped back on the PNG's home market, with devastating results for domestic suppliers like Cloudy Bay. Bob Tate shares de Fegely's concerns about the costs of certification. 'In PNG, most companies aren't producing significant volumes. SMEs in particular will find it very hard to make the investment in those systems. Indeed, he notes that the International Tropical Timber Council has called on timber importing countries to adopt common standards to make it easier for developing countries to comply. 'It's hard to know which regulation to comply with,' he said. SABL enquiry interim report The EU decision came shortly before an interim report into the possible illegal allocation of land to forestry interests in PNG. The Commission of Inquiry into Special Agricultural and Business Leases (SABLs) delivered its interim report to Prime Minister Peter O'Neill last week While we will have to wait for the final report for details of the handling of the 72 SABLS under examination, O'Neill suggested that the interim report revealed enough to indicate some government departments had 'fundamentally misunderstood their role and the legal requirements'. 'In other instances, the agency has simply failed to administer the law and applicants and developers have enjoyed a free run,' said O'Neill in a statement.
